Corey True, Student Council President addressed board and handed the gravel off to R. J. Jackson, who will be the new president for the 2014-2015 school year. R.J. gave a short report on upcoming events.

Amber Martin, Food Service Director addressed the board regarding the nutrition standards for all foods sold in school. The board is very concerned that our students are not getting enough to eat and were asking Amber what can be done to serve more food to our students. There was

much discussion on what we can and can't do to get more food to our students in addition to the lunch that is served.

A motion was made by Odle, seconded by Krone, to approve the science textbook recommendations and purchases for the jr.-sr. high school, as presented by the administration. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Shamburg, seconded by Riemann, to approve the technology purchases of \$26,400 for business lab computers and \$10,600 for Chromebooks for the jr.-sr. high school staff, as presented by the administration, for the 2014-2015 school year. These will be purchased from CDW-G. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Shamburg, seconded by Krone, to approve a new Capital Outlay resolution for 5 years, not to exceed 8 mills. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Shamburg, seconded by Riemann, to approve patching the jr.-sr. high school parking lot not to exceed \$45,000. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Odle, seconded by Shamburg, to hire Dave Bieberly from Bieberly Construction as our architect for the Beloit Elementary School Building project. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Krone, seconded by Odle, to approve the Special Education extended school contracts as recommended by the special education director. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Riemann, seconded by Krone, to approve a summer school teacher contract for Cay Wildfong and for a teacher aide, to be named later, if numbers increase. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Odle, seconded by Krone, to approve the driver education contracts for Terri Engelbert and Brad Mason. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Odle, seconded by Shamburg, to approve the certified staff recommendations, as presented by administration with the exception of Duff Watson whose name needs to be striked out on the list. (Lists attached). Motion carried: 6 Yeas, 0 Nays.

A motion was made by Odle, seconded by Krone, to approve the classified staff recommendations, as presented by administration. (Lists attached). Motion carried: 6 Yeas, 0 Nays.

Krone moved that the Board of Education go into executive session at 9:35 P.M. for the purpose of discussing personnel matters on non-elected personnel and their contractual obligations because if this matter were discussed in open session it might invade the privacy of those discussed and that the Board of Education reconvene into open session at 9:50 P.M. in this room
