The Superintendent gave an update on the election. The votes have not been canvassed yet. The Superintendent gave an update on the Southern Cloud District disorganization. There were 150 “yes” votes to disorganize and 42 “no” votes. Cloud County will canvas the votes on November 17th. The other five school boards can’t vote on the disorganization until the votes have been canvassed by Cloud County. The Superintendent gave an update on the USD 273 Education Foundation. He said that Justin Emmot has broken ground for the concession stand. The Superintendent said the legislature discussed the funding formula. They also discussed changing the reimbursed transportation from 2.5 miles to 2.0 miles but not in the city. The state department wanted to have the district list the things their district is doing great. Therefore, cards were given to each board member to state something they think the district does well.

The Superintendent gave an update on the bond project. The construction is about 1.5 weeks behind where they want to be, however, they are still ahead of schedule. The Fire Marshall has set them back. The bidding process will be starting soon for the 4 units at the high school.

A motion was made by Thompson, seconded by Ludwig, to approve the ½ day out of school on December 19, 2025 if the buildings meet their Food Drive goal. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Krier, seconded by Cousland, to approve the additions to the coaching list – Dave Elam, part-time high school wrestling and part-time junior high wrestling; and Mindy Hilt, junior high cheer sponsor. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Adams, seconded by Ludwig, to approve the building principal acquire an activities card to be used only for Trojan Threads and Trojan Grounds with a max of \$2,000. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Thompson, seconded by Cousland, to approve the Grow Your Own application for Jayne Pierson. Motion carried: 6 Yeas, 0 Nays.

The superintendent search committee was discussed. Depending on the number of candidates selected, the interview phase may span several days. Meetings will be open when the board meets; however, all interviews and discussion of candidates will be in executive session. No action was taken.

A motion was made by Krier, seconded by Cousland, to adjourn the board meeting. Meeting adjourned at 7:53 PM. Motion carried: 6 Yeas, 0 Nays.
