Amanda McGuire gave a Parents As Teachers Report. She reported that they were awarded the Blue Ribbon National Award. She thanks the board for their support to continue the program.

A motion was made by Krier, seconded by Budke to accept the resignation and terms of the termination from Baylee Kampfe, School Intern Psychologist. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Odle, seconded by File, to approve the Student Council's request to dismiss school half day early (December 20, 2019) for Christmas break if the food drive goals are met. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Salcido, seconded by Budke, to approve the changes and updates to the Supplemental coaching/sponsors list for the 2020-2021 school year, as presented by administration. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Budke, seconded by Ludwig, to approve the superintendent's recommendation that the class account associated with the exiting senior class be closed on June 30 of the graduating year and that any funds remaining prior to June 30 be used for school improvement and that all classes prior to the 2019 school year that have not been closed will be closed with this motion. Motion carried: 7 Yeas, 0 Nays.

A motion was made by File, seconded by Ludwig, to approve the Policies and Procedures for the Transitional Learning Center, as presented by Mrs. Niemczyk. Motion carried: 7 Yeas, 0 Nays.
