The Superintendent introduced Emily Benedick, Mitchell County Economic Development Director, who discussed the Neighborhood Revitalization contract. Krier and Stillwell thought it might be ok to opt out for these two years with the bond. Zach Snethen with HTK Architects was then introduced to discuss the reason behind the need to move the Bond election. It is due to the State of Kansas making the March 19, 2024 election a primary election. Therefore, the district will need to move the special election farther out in the year. After speaking with Heather Weston, Mitchell County Clerk, HTK Architects thought April 18, 2024 would be the best date for the special election. This will allow for any non-registered voters the time to register. The Superintendent explained to the Board that our board policies are the next district for the State to work on. The State Department said our policies should be done by the end of January.

A motion was made by Krier, seconded by Ludwig, to approve the addition of Keith Kresin, Assistant High School Girls Basketball Coach and Kevin Harris as Assistant High School Track Coach. Motion carried: 7 Yeas, 0 Nays.

Thompson moved that the Board of Education adopt a policy to determine the number of nonresident students that the school district has the capacity to accept in each grade Kindergarten—8<sup>th</sup> grade and program grades 9—12 for each school of the school district pursuant to K.S.A. 72-3123, and amendments thereto, Johnson seconded. Motion carried: 7 Yeas, 0 Nays.
