The Superintendent notified the Board that the Coffee Shop students will be at the March board meeting. He also explained that the district needs to look into a discipline model that will be a common voice between the elementary school and the jr-sr high school. The superintendent has asked the BICC committee to look at other curriculum models. The Superintendent gave an update on NCKC4 explaining that currently BJSHS has 9 pathways and next year there plans to be 12. The Superintendent listed the CMAR (Construction Manager At-Risk) committee: Jason Johnson, Joe File, Kelsey Adams, Jim Johnson, Jeff Travis and Tiffany Schroeder. They will meet tentatively March 3, 2023 to determine the short list notification, March 6, 2023 to give the facility tour, and March 24, 2023 to perform the Phase 3 interviews. The Superintendent discussed with the board his concern regarding 2022-23 student hours being closely met if parent-teacher conferences are not able to be held at the scheduled time due to inclement weather. The superintendent informed the board that the district will be taking sealed bids for the 1994 Ford F-150 pickup and the 2004 Chevy Suburban. Bids will be opened on March 20, 2023.

Grady Seyfert gave the Student Council Report.

Addison Beaumont gave the Jag-K Report.

Vicki Jackson gave the PTO Report.
