The Superintendent discussed the summer enrichment program. The district has received a \$1,400 donation from Solomon Valley Bank for the program which will help pay for the two instructors salaries. The superintendent addressed the renewal of the district's health insurance. At this point, it looks like there will be a 19.1% increase in premiums. At this time last year, the district claims totaled \$1,496,000. This year, the claims total is already at \$1,182,000. The superintendent has started looking at salaries for next year. He is thinking of adding \$1,200 to the base and possibly a 2.25% increase for staff not on the salary schedule. The 3 year old preschool packets were made available to parents. 53 packets were picked up by parents and 51 of them have been returned already. Currently, we have 32 students enrolled in the 3 year old preschool. The superintendent would like to find another preschool teacher so the district could add two more sessions. Robert McCreight and Eric Ingram have been getting quotes for new technology for next school year. However, they have found out that the quotes are only good for 8-15 days. The district is looking at purchasing 130 chrome books, a VLAN project and VOIP project. VLAN is devices that allow you to connect to other devices such as security cameras and phone systems. The VOIP project is a new telephone system that will be internet based. The superintendent is in agreement with approving the board policies section G through GOAD. Activity busses are the next item the superintendent discussed. The large white activity bus is over 10 years old. Therefore, the bus company will replace this bus with a newer bus with 8,900 miles. The superintendent discussed KESA stating that the KESA team decided the district would focus on quality instruction for the 2026-27 school year. The 2024-25 graduation is set for Saturday, May 10, 2025. The superintendent asked which board members will be in attendance for the graduation. Amber Krier, Kelsey Adams, Joe File and Tony Thompson will be attending. There are several activities scheduled at the same time as the May school board meeting. Therefore, it was decided to have the May board meeting start at 5:30PM.

Olivia Wright gave the Student Council Report.

Leanne Litton gave the Site Council report.

Janet Porter gave the PTO report.

The superintendent gave an update on the school bond. Mr. Travis looked at mobile classrooms that will house two classrooms and two bathrooms. At this time, he is not exactly sure where this classroom would sit on the elementary school campus. There would need to be water and electrical hooked up to the mobile classroom.

A motion was made by Krier, seconded by Ludwig, to approve the last day of school as a half day in order to allow staff to be available to help with the league track meet. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Stillwell, seconded by Cousland, to approve Deb Beals and Cindy Loy to paint for the district this summer for \$12.50 per hour. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Ludwig, seconded by Stillwell, to approve Dawn Harmon for custodial help for the district this summer for \$12.50 per hour. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Krier, seconded by Adams, to approve Marshal Musil to mow for the district this summer for \$12.50 per hour. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Adams, seconded by Stillwell, to approve Cris Adams and Stephanie Litton to teach the Summer Enrichment Program for the district for \$2,500 each this summer. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Ludwig, seconded by Krier, to approve the OPAA! yearly renewal. This will be year 2 of 5. Motion carried: 6 Yeas, 0 Nays.

Stillwell made a motion to approve the purchase of 130 chromebooks and licenses from Imagequest for \$42,236.02 and the VLAN project along with supplies from CDW-G for \$15,816.50. The motion was seconded by Cousland. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Ludwig, seconded by Adams, to approve the board policies section GA through GOAD. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Krier, seconded by Ludwig, to approve the board policy IDEA – Student Privacy Policy. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Adams, seconded by Stillwell, to approve the board policy JBC – Enrollment. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Stillwell, seconded by Ludwig, to approve the board policy JBCC– Enrollment of Nonresident Students. Motion carried: 6 Yeas, 0 Nays.
