Katie Schroeder gave the PTO reports. She presented a proposal for elementary school playground equipment. The proposal is for \$71,450 which does not include the rubber mulch. They are applying for a grant for the cost of the rubber mulch which would be \$17,000. PTO will contribute \$30,000 towards the purchase of the playground equipment.

A motion was made by S. Odle, seconded by T. Odle, to approve a bid from B Electric LLC for \$32,483.00 for new stage lighting for the Beloit Jr.-Sr. High School. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Budke, seconded by File, to approve a bid from Salina Glass for \$9,287 for new Beloit Elementary School entry doors. Motion carried: 6 Yeas, 0 Nays.
