There were no reports from Elementary Site Council and PTO.

Karen Niemczyk informed the board that she has changed the title of Alternative Learning Center (ALC) to Transitional Crisis Center (TCC).

Budke moved that the Board of Education go into executive session at 7:35 p.m. for the purpose of consultation with Board legal counsel on matters which are privileged in the attorney/client relationship which if discussed in open session would waive that privilege and that the Board of Education reconvene into open session at 8:00 p.m. in this room with Jeff Travis, Jim Johnson, Casey Seyfert, Karen Niemczyk, Brady Dean, Cassie Kopsa and Doris Gasper remaining. The motion was seconded by Riemann. Motion carried: 6 Yeas, 0 Nays.

The meeting reconvened into open session at 8:00 p.m.

Budke moved that the Board of Education go into executive session at 8:00 p.m. for the purpose of consultation with Board legal counsel on matters which are privileged in the attorney/client

relationship which if discussed in open session would waive that privilege and that the Board of Education reconvene into open session at 8:10 p.m. in this room with Jeff Travis, Jim Johnson, Casey Seyfert, Karen Niemczyk, Brady Dean, Cassie Kopsa and Doris Gasper remaining. The motion was seconded by Riemann. Motion carried: 6 Yeas, 0 Nays.

The meeting reconvened into open session at 8:10 p.m.

A motion was made by File, seconded by Salcido, to approve a \$3,000 stipend for Cris Adams as Director/Teacher and \$2,000 for Stephanie Litton as Assistant Director/Teacher for the Summer Enrichment Academy. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Riemann, seconded by Budke, to approve a five cent per lunch increase for student lunches for the 2019-20 school year. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Ludwig, seconded by Budke, to approve the additional special education extended school year contracts as presented by the special education director. (List attached). Motion carried: 6 Yeas, 0 Nays.

A motion was made by File, seconded by Ludwig, to approve the Mitchell County Partnership for Children/Mitchell County Early Learning Center staff for 2019-2020, as presented by the administration. (List attached) Motion carried: 6 Yeas, 0 Nays.

A motion was made by Budke, seconded by Ludwig, to approve the classified staff recommendations for 2019-2020, as presented by the administration. (List attached) Motion carried: 6 Yeas, 0 Nays.

A motion was made by File, seconded by Budke, that pending Kansas Supreme Court approval, \$1,250 will be placed on the teacher's base salary, taking the starting teacher base salary from \$35,000 to \$36,250. All other salary and wages will be increased by 3%. All steps and movement with salary will be honored. The Board of Education also agrees to a one-time bonus of \$150 for all employees. The bonus will be paid to new teachers to the district in August of 2019 and all others in December of 2019 at payroll time. Lastly, the Board of Education will move extra duty pay from \$8.00 to \$8.50 starting with the 2019-2020 school year. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Ludwig, seconded by Salcido, to approve the amendment for the JAG-K (Jobs for America's Graduates-Kansas) for 2019-2020 school year. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Budke, seconded by Ludwig, to approve the additions for the coaching and sponsor/extra duty list, as recommended by administration. Motion carried: 6 Yeas, 0 Nays.

Riemann moved that the Board of Education go into executive session at 8:25 p.m. for the purpose of discussing matters relating to actions adversely or favorably affecting a person as a student because if this matter were discussed in open session it might invade the privacy of those discussed and that the Board of Education reconvene into open session at 8:40 p.m. in this room

with Mr. Travis and Mr. Seyfert remaining. The motion was seconded by File. Motion carried: 6 Yeas, 0 Nays.

The meeting reconvened into open session at 8:40 p.m.

A motion was made by Budke, seconded by Riemann, that the meeting adjourn. Meeting adjourned at 8:45 p.m. Motion carried: 6 Yeas, 0 Nays.
