A motion was made by Thompson, seconded by File, to approve the 3-year district filter quote presented by SHI for \$16,065.00. Motion carried: 6 Yeas, 0 Nays.

Krier made the motion to approve the Parents as Teachers employee list for the 2023-2024 school year as presented by the PAT Director, seconded by Ludwig. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Krier, seconded by Thompson, to approve the stipends for Summer Enrichment of \$2,500 for Cris Adams and Stephanie Litton. Motion carried: 6 Yeas, 0 Nays.

A motion was made by File, seconded by Ludwig, to approve the 2023-2024 supplemental duty assignments as presented by administration. (List attached). Motion carried: 6 Yeas, 0 Nays.
