A motion was made by S. Odle, seconded by Budke, to approve the Parents as Teachers staff and their salary increases as presented. Motion carried: 5 Yeas, 0 Nays.

A motion was made by S. Odle, seconded by Budke, to approve the Mitchell County Partnership for Children employee list & rate increases as presented by Mr. Dean. Motion carried: 5 Yeas, 0 Nays.

A motion was made by T. Odle, seconded by Riemann, to approve the Beloit Elementary School Handbook updates as presented by Mr. Dean. Motion carried: 5 Yeas, 0 Nays.

A motion was made by Riemann, seconded by S. Odle, to approve Mitchell County Partnership for Children health and safety educator/Early Learning Center assistant director job descripton. Motion carried: 5 Yeas, 0 Nays.

A motion was made by S. Odle, seconded by T. Odle, to approve a five year lease with the City of Beloit and the Mitchell County Partnership for Children/Mitchell County Early Learning Center for \$18,000 per year. Motion carried: 5 Yeas, 0 Nays.

A motion was made by S. Odle, seconded by Budke, to approve the Extended School Year updates as presented by the special education director. (List attached) Motion carried: 5 Yeas, 0 Nays.

A motion was made by Riemann, seconded by S. Odle, to approve a contract for the provision of education services between USD273/Special Education Cooperative and USD 333 Concordia as presented by Mrs. Niemczyk. Motion carried: 5 Yeas, 0 Nays.

S. Odle moved to adopt of the following resolution:

WHEREAS, on the 13th day of June, 2016, the Board of Education of said Unified School District No. 273, Mitchell County, Kansas, by resolution duly adopted, took action to notify Steven K. Meier, of the board's intent to nonrenew his contract as a teacher for the 2016-2017 school year; and;

WHEREAS, the clerk of the board of education gave written notice to Steven K. Meier on the 10th day of May 2016, that it was the intent of the board of education to nonrenew his contract for the 2016-2017 school year;

WHEREAS, after extensive consideration and thorough discussion, the board has determined that the matter should be resolved as follows:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF UNIFIED SCHOOL DISTRICT NO. 273, MITCHELL COUNTY, KANSAS:

Section 1. That the contract of Steven K. Meier be nonrenewed for the 2016-2017 school year;

Section 2. That the clerk of the board of education give, personally or by United States mail, Steven K. Meier a signed copy of this resolution.

ADOPTED by the Board of Education of Unified School District No. 273, Mitchell County, Kansas, the 13th day of June, 2016.

Motion was seconded by Budke. Motion carried: 5 Yeas, 0 Nays.

A motion was made by Riemann, seconded by T. Odle, to approve the purchase of a portable restroom from Portable Restroom Trailers, LLC in the amount of \$18,750 plus \$1,380 for freight for a total of \$20,130, for use at Trojan stadium. Motion carried: 5 Yeas, 0 Nays.

A motion was made by Riemann, seconded by S. Odle, to approve the social studies textbook upgrades as approved by the Beloit Instruction and Curriculum Committee and presented by the superintendent. The total purchase is \$37,234.15. Motion carried: 5 Yeas, 0 Nays.

A motion was made by S. Odle, seconded by Budke, to approve that the Clerk and Superintendent work together and have the authority to make the necessary transfers to end Fiscal 2016. Motion carried: 5 Yeas, 0 Nays.

A motion was made by Budke, seconded by S. Odle, to increase the student and adult lunch prices by 10 cents a meal for the 2016-2017 school year, as required by the federal lunch reimbursement program. Prices are: K-6 students \$2.60; 7-12 \$2.80; Adults \$3.60. Motion carried: 5 Yeas, 0 Nays.

S. Odle moved that the Board of Education go into executive session at 7:45 p.m. for the purpose of discussing matters relating to actions adversely or favorably affecting a person as a student because if this matter were discussed in open session it might invade the privacy of those discussed and that the Board of Education reconvene into open session at 8:00 p.m. in this room with Mr. Travis and Mr. Seyfert remaining. The motion was seconded by Budke. Motion carried: 5 Yeas, 0 Nays.

The meeting reconvened into open session at 8:00 p.m.
