The Superintendent gave an update on the summer projects. The Rooftop units have gone up to \$175,000 each including use of a crane. The track team has \$2,000 in donations for the high jump pits and the district has received \$20,900 from the insurance company. The remaining will come out of district funds. The Superintendent updated the board on health insurance: to move to the Gravie self-funded would have a 19% increase, BCBS self-funded would be a 16% increase, Gravie fully funded would be a 6% increase, but BCBS fully funded would be a 9.5% decrease. The Superintendent stated that the State has said to figure a 20% increase in expenses for fuel and utilities. The Superintendent suggested a 1.5% increase for classified staff and \$850 increase in the base for certified staff on the salary schedule. May 13, 2023 is scheduled for 2022-2023 graduation. HTK would like the contract changed to an hourly rate.
