A motion was made by Stillwell, seconded by Ludwig, to set the regular board meetings for the 2023-2024 fiscal year on the second Monday of each month, except March when it will be on the first Monday due to Spring Break and said meetings be at 6:30 P.M. at the Board of Education Office, under the Home Rule Authority. Motion carried: 6 Yeas, 0 Nays. With this motion the following were also approved for the 2023-2024 school year.

A motion was made by Ludwig, seconded by Krier, to approve/establish the Petty Cash Accounts (Board Office \$1,500.00; Elementary School \$1,000.00; Jr.-Sr. High School \$1,000.00). Motion carried: 6 Yeas, 0 Nays.

A motion was made by Stillwell, seconded by Ludwig, to adopt the early payment request policy per KSD 12-105 (b) for fiscal year ending June 30, 2024. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Johnson, seconded by Ludwig, to waive the provisions of GAAP and fixed asset accounting for FY24. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Krier, seconded by Ludwig, to adopt resolutions for Beloit Elementary and Beloit Jr.-Sr. High School activity funds. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Ludwig, seconded by Adams, to authorize the superintendent to dispose of surplus property during the 2023-2024 school year. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Johnson, seconded by Adams, to approve the addition of the Class of 2027 for the Beloit Jr.-Sr. High School activity fund. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Ludwig, seconded by Stillwell, to set the following district credit card limits: Jeff Travis \$5,000; Christie Gerdes \$2,000; Casey Seyfert \$2,000; Janet Porter \$2,000; Garry Lowry \$2,000; Kyle Beisner \$2,000; Cassie Kopsa \$2,000 and all other credit cards with a \$2,000 limit. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Johnson, seconded by Ludwig, to approve year 4 of 5 bus contract for DS Busline. Motion carried: 6 Yeas, 0 Nays.

A motion was made by Krier, seconded by Adams, to approve the NCKC4 membership fee of \$6,000 annually. Motion carried: 6 Years, 0 Nays.

The superintendent introduced Jameon Schwarz with Black Wolf Sports Surfacing attending by Zoom. Jameon explained the process of renovating the two lower tennis courts expecting to cost \$63,500. The A/C rooftop unit for the Beloit Jr-Sr High School is planned to be here next week. Blue Cross/Blue Shield was the lowest health insurance bid received. However, it is still a 17% increase from last year.

Krier and Adams left the meeting at 7:15 PM.

The superintendent continued with his report letting the board know of the Board Tour planned for Friday, August 11th beginning at the Special Education office at 4:30 PM, then continuing to BHS, then on to BES and ending the evening with a meal at Ringneck Ranch, Tipton KS. Summer projects were updated to the board and the graduation date was planned for May 11, 2024.
