Heather File gave the PTO Report.

There was no Site Council Report.

Colson Riemann gave the Student Council Report.

The superintendent reported on the beginning of the year activities; Summer work update; Beloit Elementary School building addition; Budget update; Building Tours and Budget Hearing.

Stephanie Simmons, a member of the AWARE team, handed out information on the Beloit Elementary School Marathon. This is an opportunity for all Beloit Elementary School students grades 1-6 to participate in a 26.2 mile marathon. It is over a 6 week period that begins September 8, 2015. They would run 3-4 days per week from 7:30 to 7:45 a.m. before school starts. Therefore they are planning on constructing a 5' x 525' sidewalk on the South end of the playground from the preschool building to the existing west sidewalk. They want to construct it inside the fence. The construction would be taken care of by the AWARE team and volunteers.

A motion was made by Budke, seconded by Riemann, to approve the sidewalk project at the Beloit Elementary School. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Shamburg, seconded by Budke, to approve Tiffany Schroeder as Interim Treasurer. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Budke, seconded by Riemann, to approve an additional \$20.00 increase in the board's contribution, per employee, for the district's health insurance. This would change the contribution from \$295.00 to \$315.00. Motion carried: 7 Yeas, 0 Nays.

A motion was made by S. Odle, seconded by Budke, to approve the new health insurance eligibility requirement that employees must average 30 hours per week during their contracted work time. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Budke, seconded by S. Odle, to approve the GARH-R Uncompensated Leaves and Absences-Released Time Policy as amended and with the addition for a request have a September 1 deadline for the 2015-2016 school year. Motion carried: 7 Yeas, 0 Nays.

A motion was made by Budke, seconded by T. Odle, to approve the purchase of an HDX activities bus from Midwest Sales in the amount of \$164,782. Motion carried: 7 Yeas, 0 Nays.

A motion was made by S. Odle, seconded by Riemann, to give the Chromebooks to the seniors, upon graduation, at the end of the school year. Motion carried: 7 Yeas, 0 Nays.
